D. Parent/ Teacher Home Visit Project

a. Motion made by L. Dean (Teacher)

- b. Motion seconded by Dr. Richardson (Teacher)
 - i. In Favor: 8 Opposed: 0
 - ii. Motion Carried: With conditions:
 - 1. Need a way to measure accountability of visits
 - 2. Willing to train all teachers
 - 3. Need a 10-teacher commitment (10% of staff) to visit before moving forward.
 - 4. All other details will be negotiated once we have enough teachers interested and on-board.
- c. **DISCUSSION**
 - i. Jodi attended a meeting from the organization and it seems to be a worthwhile program to continue to explore for North.
 - 1. J. Gonzales reviewed the 5 non-negotiables of the plan. This is available as a 2-page document.
 - 2. A 3.5 hours training for teachers over two days
 - 3. \$5,000 blanket cost to train regardless of number of teachers getting trained.
 - a. Other costs will need to be calculated
 - b. Looking at approx. \$30,000 (training, 50 hours at \$50-hour time card, 10 teachers, 10 kids per teacher, no fixed charges included in this figure) 100 kids visited.
 - 4. We would like to see if similar schools in our area or high schools are using the program and how so that we can get some ideas.
 - 5. Is it staff and teachers or just teachers? Open to including other staff ie: Instructional aids.
 - 6. Between certificated teachers and counselors, we have approx. 90 people.
 - 7. Teachers that volunteer to “pilot” this program would have to be willing to do it after school hours and on weekends. We can’t have them out of the classroom 20 days for this. No time carding during the school day do to double dipping.
 - a. There’s an idea that more teachers would be willing to do it outside the school day.
 - 8. It is expensive so we need try and ensure that the home visits are being done for the right reasons and not just to be time carded. We need to look at the data at the end to see if this had a positive effect on students or if it was just checking a box. We have to have a measuring tool for effectiveness.
 - 9. The dollar amount is not an issue for 2021/2022 so if we are going to try, it is now.
 - 10. There needs to be a meaningful reflection piece
 - 11. Try for strategic pairing between the teachers: Teacher A and Teacher B both have Student 1.
 - a. Ask teachers to volunteer in pairs to do this so that it is more strategic.
